NOTIFICATION

In exercise of the powers conferred by sub-section (1) of Section 8-A of the Karnataka Sales Tax Act, 1957 (Karnataka Act 25 of 1957), the Government of Karnataka hereby exempts with effect from the First day of April 2015, the tax payable by a dealer under Section 5 of the said Act, on the sale of diesel for supply to fishermen for use in fishing activities as per the indents issued on a monthly basis by the Director of Fisheries, Government of Karnataka, during the period 01.04.2015 to 31.05.2015 as under:-

Sl.No.	Period	Quantity of Diesel to be Released for the month
1	01.04.2015 to 30.04.2015	18000 kilo litres
2	01.05.2015 to 31.05.2015	18000 kilo litres

Provided that the unutilized quantity of diesel specified for any month may be released for the immediately succeeding month or any quantity of diesel released in excess of the quantity specified for any month shall be adjusted in the quantity specified for the succeeding months by the Director of Fisheries, Government of Karnataka so as to however not exceed thirty-six thousand kilo litres for the period from 01.04.2015 to 31.05.2015.
