In exercise of the powers conferred by sub-section (1) of Section 8-A of the Karnataka Sales Tax Act, 1957 (Karnataka Act 25 of 1957), the Government of Karnataka hereby exempts with immediate effect and upto thirty-first day of March 2018, the tax and cess payable under Section 25-B by a manufacturer of sugar (including Khandasari sugar) subject to the condition of clearing of dues of the farmers relating to the financial years of 2013-14, 2014-15 and 2015-16 as per the Fair and Remunerative Price (FRP) fixed under Sugar (Control) Order, 1966 and the State Advisory Price (SAP) as fixed under the Karnataka Cane (Purchase and Supply) Act, 2013 on or before 30<sup>th</sup> June 2016 and production of clearance certificate to the effect of clearing dues as certified by Commissioner for Cane Development & Director of Sugar, Government of Karnataka, in the form specified below and submission of such clearance certificate to the jurisdictional Joint Commissioner of Commercial Taxes (Administration), VAT Division of the Department of Commercial Taxes, Government of Karnataka, on or before 30<sup>th</sup> June 2016.
